- Forest policy of 1993—Production and environmental concern are two equally important goals for forestry
- The Swedish Forestry Act sets the frames and basic requirements for forestry
- Voluntary commitments important—“freedom with responsibility”

# Dialogue process started in 2011

- Facilitated by the Swedish Forest Agency (SFA)
- Participation by forestry, SFA and other authorities, non-governmental organizations and scientists
- **Develop strategic objectives for good environmental consideration**
- Collaborative group manage the objectives
- 4 work groups: Nature conservation, Soil and water, Outdoor recreation, Cultural heritage environments
- Excursions, workshops, meetings and seminars

# Excursion ditch cleaning

- Strategic objectives for good environmental consideration should reflect the expected level of consideration based on the forestry sector responsibility.
- This level should be higher than stipulated by the Forestry Act.

# Strategic objectives: Soil and water

- Forest buffers near lakes and watercourses
- Watercourse crossings during off-road transportation
- Off-road transportation
- Ditch cleaning operations
- Protective ditching
- Dimensioning overland flow areas

# Forest buffers near lakes and watercourses: Strategic objectives for thinning

Some examples

- A forest buffer perceived to be functional is not thinned.
- No thinning in discharge areas bordering surface water.
- The forest buffer is not cleaned.
- No rutting in or close to watercourses and lakes.

- New strategic objectives are being developed
- Implementation by practical forestry
- Evaluation
